18 I, the undersigned, say, on information and belief, that in the County of San Mateo, State of
19 California:

20 **COUNT 1: PC288(a) (Felony)**

21 On or between September 19, 2022 and September 18, 2023, in the County of San Mateo, State of
22 California, the crime of Lewd Act Upon A Child in violation of PC288(a), a Felony, was committed
23 in that RAFAEL PRADO did willfully, unlawfully, and lewdly commit a lewd and lascivious act
24 upon and with the body and certain parts and members thereof of CONFIDENTIAL VICTIM (DOB
25

1 09/19/09), a child under the age of fourteen years, with the intent of arousing, appealing to, and
2 gratifying the lust, passions, and sexual desires of the said defendant, RAFAEL PRADO and the said
3 child, TO WIT: SODOMY.

4
5 NOTICE: The above offense is a violent felony within the meaning of Penal Code
6 667.5(c). NOTICE: Conviction of this offense will require you to register pursuant to Penal Code
7 section 290. Willful failure to register is a crime. NOTICE: Being charged with this criminal offense
8 can result in mandatory pre-conviction HIV/AIDS testing and disclosure of the results to a victim and
9 the Chief Medical Officer of the jail or prison facility where you are incarcerated pursuant to Penal
10 Code Section 1524.1 and Health and Safety Code section 121055 following a probable cause hearing
11 resulting in a court order. NOTICE: this is a serious felony pursuant to PC1192.7(c).

13 **ENHANCEMENT 1**

14 **PC1203.066(a)(8): Special Allegation-Substantial Sexual Conduct-288, 288.5**

15 It is further alleged pursuant to Penal Code section 1203.066(a)(8) as to Count 1 that the victim,
16 CONFIDENTIAL VICTIM (DOB 09/19/09), in the above offense was under the age of 14 years and
17 the defendant, RAFAEL PRADO had substantial sexual conduct with CONFIDENTIAL VICTIM
18 (DOB 09/19/09).

19
20 **COUNT 2: PC288(a) (Felony)**

21 On or between September 19, 2022 and September 18, 2023, in the County of San Mateo, State of
22 California, the crime of Lewd Act Upon A Child in violation of PC288(a), a Felony, was committed
23 in that RAFAEL PRADO did willfully, unlawfully, and lewdly commit a lewd and lascivious act
24 upon and with the body and certain parts and members thereof of CONFIDENTIAL VICTIM (DOB

1 09/19/09), a child under the age of fourteen years, with the intent of arousing, appealing to, and
2 gratifying the lust, passions, and sexual desires of the said defendant, RAFAEL PRADO and the said
3 child, TO WIT: ORAL COPULATION.
4

5 NOTICE: The above offense is a violent felony within the meaning of Penal Code
6 667.5(c). NOTICE: Conviction of this offense will require you to register pursuant to Penal Code
7 section 290. Willful failure to register is a crime. NOTICE: Being charged with this criminal offense
8 can result in mandatory pre-conviction HIV/AIDS testing and disclosure of the results to a victim and
9 the Chief Medical Officer of the jail or prison facility where you are incarcerated pursuant to Penal
10 Code Section 1524.1 and Health and Safety Code section 121055 following a probable cause hearing
11 resulting in a court order. NOTICE: this is a serious felony pursuant to PC1192.7(c).

13 ENHANCEMENT 1

14 PC1203.066(a)(8): Special Allegation-Substantial Sexual Conduct-288, 288.5

15 It is further alleged pursuant to Penal Code section 1203.066(a)(8) as to Count 2 that the victim,
16 CONFIDENTIAL VICTIM (DOB 09/19/09), in the above offense was under the age of 14 years and
17 the defendant, RAFAEL PRADO had substantial sexual conduct with CONFIDENTIAL VICTIM
18 (DOB 09/19/09).

20 **COUNT 3: PC288(c)(1) (Felony)**

21 On or between September 19, 2023 and April 29, 2025, in the County of San Mateo, State of
22 California, the crime of Lewd Act Upon A Child in violation of PC288(c)(1), a Felony, was
23 committed in that RAFAEL PRADO did willfully, unlawfully and lewdly commit a lewd and
24 lascivious act upon and with the body of CONFIDENTIAL VICTIM (DOB 09/19/09), who was 14
25

1 and 15 years old, with the intent of arousing, appealing to, and gratifying the lust, passions, and
2 sexual desires of the child or the defendant, who was at least 10 years older than CONFIDENTIAL
3 VICTIM (DOB 09/19/09), TO WIT: SODOMY LAST TIME.

4
5 NOTICE: Conviction of this offense will require you to register pursuant to Penal Code section 290.
6 Willful failure to register is a crime. NOTICE: Being charged with this criminal offense can result in
7 mandatory pre-conviction HIV/AIDS testing and disclosure of the results to a victim and the Chief
8 Medical Officer of the jail or prison facility where you are incarcerated pursuant to Penal Code
9 Section 1524.1 and Health and Safety Code section 121055 following a probable cause hearing
10 resulting in a court order.

11
12 **COUNT 4: PC288(c)(1) (Felony)**

13 On or between September 19, 2023 and April 29, 2025, in the County of San Mateo, State of
14 California, the crime of Lewd Act Upon A Child in violation of PC288(c)(1), a Felony, was
15 committed in that RAFAEL PRADO did willfully, unlawfully and lewdly commit a lewd and
16 lascivious act upon and with the body of CONFIDENTIAL VICTIM (DOB 09/19/09), who was 14
17 and 15 years old, with the intent of arousing, appealing to, and gratifying the lust, passions, and
18 sexual desires of the child or the defendant, who was at least 10 years older than CONFIDENTIAL
19 VICTIM (DOB 09/19/09), TO WIT: ORAL COPULATION LAST TIME.

20
21 NOTICE: Conviction of this offense will require you to register pursuant to Penal Code section 290.
22 Willful failure to register is a crime. NOTICE: Being charged with this criminal offense can result in
23 mandatory pre-conviction HIV/AIDS testing and disclosure of the results to a victim and the Chief
24 Medical Officer of the jail or prison facility where you are incarcerated pursuant to Penal Code

1 Section 1524.1 and Health and Safety Code section 121055 following a probable cause hearing
2 resulting in a court order.

3
4 **COUNT 5: PC288(c)(1) (Felony)**

5 On or between September 19, 2023 and April 29, 2025, in the County of San Mateo, State of
6 California, the crime of Lewd Act Upon A Child in violation of PC288(c)(1), a Felony, was
7 committed in that RAFAEL PRADO did willfully, unlawfully and lewdly commit a lewd and
8 lascivious act upon and with the body of CONFIDENTIAL VICTIM (DOB 09/19/09), who was 14
9 and 15 years old, with the intent of arousing, appealing to, and gratifying the lust, passions, and
10 sexual desires of the child or the defendant, who was at least 10 years older than CONFIDENTIAL
11 VICTIM (DOB 09/19/09), TO WIT: ORAL COPULATION ANOTHER TIME.

12
13 NOTICE: Conviction of this offense will require you to register pursuant to Penal Code section 290.
14 Willful failure to register is a crime. NOTICE: Being charged with this criminal offense can result in
15 mandatory pre-conviction HIV/AIDS testing and disclosure of the results to a victim and the Chief
16 Medical Officer of the jail or prison facility where you are incarcerated pursuant to Penal Code
17 Section 1524.1 and Health and Safety Code section 121055 following a probable cause hearing
18 resulting in a court order.

19
20 **COUNT 6: PC311.11(a) (Felony)**

21 On or about June 17, 2025, in the County of San Mateo, State of California, the crime of Possession
22 Of Child Or Youth Pornography in violation of PC311.11(a), a Felony, was committed in that
23 RAFAEL PRADO knowingly possessed or controlled a representation of information, an image and
24

1 data, the production of which involved the use of a person under 18 years of age, knowing that the
2 matter depicted a person under 18 years of age personally engaging in or simulating sexual conduct.

3 NOTICE: Conviction of any of the above felony counts requires relinquishment of firearms,
4 ammunition and ammunition feeding devices.

5
6 Pursuant to Penal Code Section 1054.5(b), the People are hereby informally requesting that
7 defendant(s) and his or her attorney provide to the People the discovery required by Penal Code
8 Section 1054.3. This is a continuing request pursuant to the provisions of Penal Code Section 1054.7.

9 I declare under penalty of perjury that the foregoing is true and correct except for those things
10 stated on information and belief and those I believe to be true.
